RE: REMOVAL OF TARIFFS FROM ENVIRONMENTAL GOODS

The Green Building Council of Australia appreciates the opportunity to provide comment to the Department of Foreign Affairs and Trade regarding the removal of tariffs from environmental goods. The GBCA believes that the removal of tariffs will deliver both immediate and ongoing benefits for our members, industry and the wider community.

The GBCA is the nation's authority on sustainable buildings, communities and cities. Our mission is to accelerate the transformation of Australia's built environment into one that is healthy, liveable, productive, resilient and sustainable. We work together with industry and government to encourage policies and programs that support our mission. We educate thousands of people each year on how to design and deliver sustainable outcomes for our buildings, communities and cities. We operate Australia's only national voluntary and holistic rating system for sustainable buildings and communities – Green Star.

The GBCA has over 780 member organisations including more than 130 building product manufacturers, suppliers and distributors (a list of these organisations can be found at Appendix A.). These organisations offer products that provide solutions for a range of issues encountered in the built environment including heat and energy management, air pollution control and testing, waste and water management, and environmental monitoring, analysis and assessment.

The removal of tariffs on environmental goods will remove a market barrier and will be a positive step towards making environmental goods more accessible, affordable and attractive. It will also provide an incentive for organisations in the product manufacturing and supply sector to grow their businesses and seek new markets.
