An exemplar project, Legion House demonstrates how cultural significance and historic architectural features can be integrated with high-tech ESD to deliver a 'best of both worlds' building.
	Legion House challenges the Australian perception that on site renewable energy equates to photovoltaic panels and wind turbines through the implementation of world leading gasification technology. The building features the application of off-grid, on site power generation fuelled by syn-gas made from waste.
	In this interactive case study, the Legion House project team will discuss how heritage, technology and sustainability have combined to deliver a 'World Leadership' Green Star office.
